

## Fee structure

### Context

As agreed by the Euroheat & Power Board during its meeting on June 26<sup>th</sup> 2018. The new fee structure is designed to replace the one which ran from 2013 to 2018 and is intended to remain in effect through 2023. The fee structure was approved by the General Assembly held on May 6<sup>th</sup> 2019 during the General Assembly.

| Non-profit organisations that are widely recognised for their activities in the district energy and which are legally based in the European Union or in the European Economic Area (EEA). The fee level will depend on the heat and cold supplies of the association's members to the network in the three (3) last consecutive years available; for active association members having joined prior to the year 2015, the reference years are fixed to the years: 2010-2011-2012. Active Associations joining after 31st December 2015 the reference year are the three (3) most recent consecutive years available requiring at least 2013, 2014 and 2015. In case only the heat supplies to the customers are known, a correction factor of +10% will be applied. New active associations benefit from a phase-in scheme, starting at 40% (with a minimum of 4.000 EUR) and increasing to 100% over a period of four years. Active members dispose of 1 vote per 4.000 EUR contribution with a maximum of 16 votes. |                              |                              |
